1. What Is Supplied Directly

Consultations, strategy sessions, reviews, and meetings, held by video call, by phone, or in person.

Speaking engagements and the material prepared for them.

Written deliverables and documentation produced for an engagement.

Occasional physical items, such as printed documentation or drives holding project files.

2. Delivery of Sessions and Services

Sessions are confirmed when they are scheduled.

Access details or location information are sent by email within one business day of booking.

Written deliverables are sent on the schedule set in the agreement for that engagement.

3. Delivery of Physical Items

Physical items ship within three to five business days of confirmation.

Tracking is sent by email when the item is dispatched.

Delivery dates given by a carrier are estimates and are not guaranteed.

Where a carrier delay or other disruption affects a shipment, you will be told.

4. Returns and Refunds

Damaged or defective items. Report within seven days of delivery, by email, with the order details and photographs. Where the claim is approved, return shipping is covered and a replacement or refund is arranged.

Incorrect items. Report within seven days of delivery. A replacement is sent and the original shipping is refunded.

Return process. Prepaid return labels are provided for approved returns. Items must be packaged securely so they are not damaged on the way back.

5. What Cannot Be Returned

Digital downloads, once access has been delivered.

Drives or media that have been opened or used.

Personalized or custom produced materials.

Consultations and sessions that have already taken place.

Where a refund is required by law, that requirement is honored regardless of the above.

6. Cancellations and Rescheduling

Cancellation and rescheduling terms for a booked session or a speaking engagement are set in the agreement for that engagement. Where no agreement sets them, contact us as early as you can and it will be worked out.

7. Pricing, Payment, and Tax

Prices are shown in U.S. dollars.

Where sales tax applies, it is calculated and shown before the transaction is completed.

Payment is processed by a third party payment processor. Full payment card numbers are not received or stored here.
